
## LED Lighting Agent

This conceptual model was realized by Eusu ShipManagement. With a stream of sensors and various data from vessels, our grey box (mathematical/statistical model) calculates the status of equipment and predicts its breakdown moment. It requires profound statistical knowledge and vessel management experience to establish the grey box, and Eusu ShipManagement has finally done it. It not only helps reduce the number of accidents and maintenance cost, but is also critical for improving your vessel into a smart ship.



As oil price increases, there are many solutions to be developed for saving fuel cost in the industry. However, many of them are hard to be proven as considerably efficient, and solution providers seem to exaggerate the results. Moreover, it is necessary to make full use of solutions in order to save fuel cost.
